Training Methodology

The training methodology balances theoretical understanding with practical application, using the 'learning by doing' approach. The course is presented in a blended learning format which includes both face-to-face and online sessions. Workshops, demonstrations, group discussions, presentations, guided online research and hands-on online materials development are some of the strategies and techniques used.

Monitoring and Evaluation Method

Record of attendance will be documented for every session throughout the duration of the course. This will include face-to-face and online sessions. Evaluation is done through in-class and online tasks. An Action Plan is a requirement for course completion.

Targeted Participants

This course is designed for English Language Teaching (ELT) practitioners and specifically for those who wish to take on the role as trainers in extending their training impact within the context of designing online courses. Participants are also expected to have basic ICT literacies.

General Terms and Conditions of Scholarship

Air Fares:

A return air ticket from the capital city of the recipient's country to Kuala Lumpur on economy class will be provided by the Government of Malaysia to participants from recipient countries with GDP per capita below USD 5,000. Therefore, some MTCP recipient countries may need to bear their own air fares. Tickets will be issued upon confirmation of acceptance.

Visa & Vaccination:

- It is mandatory that all MTCP participants adhere to the Visa With Reference (VWR) application procedure.
- Person seeking to enter Malaysia must be in possession of a valid passport or other internationally recognised travel document and visa if required. Passport or other travel document must be valid for at least 6 months beyond the period of stay allowed in Malaysia.
- Successful applicants are required to submit a coloured photocopy of the first page of their valid passports, a current coloured passport sized photo and a letter of acceptance to the Training Institution/programme organiser.
- The Training Institution/programme organiser will apply for VWR at the Department of Immigration in Malaysia for immigration processing and obtaining specific VWR Approval Letter for the applicants. Upon approval, a copy of this VWR Approval Letter will be forwarded to the participants who will then collect their respective VWR from the nearest Malaysian Mission.
- Applicants who have received the specific VWR Approval Letter are required to obtain a VWR stamp at the specified Malaysian Mission before entering Malaysia.
- Expenditures on all visa-related fees, airport-tax/airport user's charge, transit insurance, excess luggage, travel tax, transit fees, domestic passenger terminal fees, phone chargers, private purchases, etc. are BORNE BY THE PARTICIPANTS. This also applies for medical check-up and vaccinations prior to travel to Malavsia.
- Participants from yellow fever endemic areas, including diplomatic and official passport holders, are required to take a mandatory vaccination for yellow fever at least ten (10) days prior to their departure to Malaysia and required to produce a Yellow Fever Vaccination Certificate at the entry point in Malaysia.

The Malaysian Technical Cooperation Programme (MTCP) was first initiated at the First Commonwealth Heads of Government Meeting (CHOGM) for Asia Pacific Region in Sydney in February 1978. It was officially launched on 7 September 1980 at the Commonwealth Heads of State Meeting in New Delhi to signify Malaysia's commitment to South-South Cooperation, in particular Technical Cooperation among Developing Countries (TCDC).
